
7. Membership


(a) Any man or woman has completed twenty one year age and who is actively associated with education in general is eligible for admission to the membership of the society at the discretion of the Committee of Management.




10. The Committee of Management shall be entrusted with the following powers :

- (i) To purchase or acquire sites, construct buildings, and sell, lease, mortgage or otherwise, raise funds on the security of buildings and other properties belonging to the society.
- (ii) To purchase all articles necessary to run the institution under its care, efficiently and economically
- (iii) To appoint the necessary staff and workers for carrying its work.
- (iv) To collect funds, receive subscription, levy fees, receive grants-in-aid and receive other money for and on behalf of the society.
- (v) To invest money in approved securities, to endorse and negotiate them for the use of the society, to open account or accounts with any scheduled bank or banks and to authorise operation thereon.
- (vi) To appoint honorary workers, to collect donations and to render such other technical or general assistance as the Committee may deem fit.
- (vii) To fill up vacancies in the Committee of Management by nomination or election, as they deem fit.
- (viii) To affiliate other institutions run on identical lines

11. The Chairman

The chairman of the society shall preside over all meetings of the Managing Committee and over the General Meetings of the Society and shall advise in the affairs of the society.

Special Powers

In emergencies, the Chairman shall have power to take action according to discretion in the interests of the society within the scope of its aims and objects.

Any action found necessary under emergent circumstances shall be reported to the Committee of Management at its next meeting for ratification.

12. In the absence of the Chairman someone from the managing Committee shall be elected to discharge the functions of the Chairman.

13. The General Secretary

The General Secretary shall have, subject to the control of the Committee of Management, power to supervise the affairs of the society. He shall be responsible for the proper upkeep and protection of the movable and immovable properties of the society including the buildings and premises of the society and for the collection of the subscriptions, donations, fees, grant-in-aid and for the proper maintenance of accounts. His receipt in writing shall be a sufficient discharge of the same.

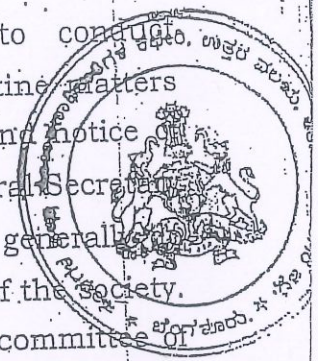

The General Secretary shall have power to conduct correspondence under his own signature on all routine matters relating to the society and it shall be his duty to send notice of meetings to members with Agenda in time. The General Secretary shall implement all the decisions of the society and generally do everything necessary for the furtherance of the work of the society. The General Secretary may, at the discretion of the committee of management, be paid a suitable honorarium or other allowances and perquisites.



The General Secretary shall submit every year a report of the activities of the Society together with a copy of the Accounts before the Committee of management for its approval.


The General Secretary shall have power to delegate part of his functions to local Secretaries and local correspondents if any, appointed for conducting the day to day affairs of the institutions running specialized courses of studies under the Society.



14. The Treasurer

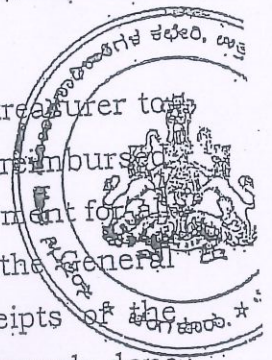

A sum not exceeding Rs.100/- may be held with treasurer to meet the emergent expenses, as an imprest to be reimbursed from time to time by the Secretary. He shall make payment for expenditure on written requisitions or vouchers from the Secretary and duly approved by him. All the receipts of the society shall be remitted to the Bank and all the withdrawals done on the signatures of the General Secretary and the Treasurer jointly. The Treasurer shall furnish the detailed accounts of the income and expenditure for every three months. At the close of every year, the overall statement of income and expenditure for the period shall also be furnished by the Treasurer.

15. Meeting of the Committee of Management

The Committee of Management shall meet at least once in every six months but normally every month. All the questions shall be decided by the majority of the members present at the meeting and shall be binding on the Society. It shall be the endeavour of the Committee to reach decisions unanimously.

The quorum for the meeting of the Committee of management shall be four (4)

16. Disqualification

The member who absents himself consecutively for two meetings without consent of the committee, shall vacate his office. If a member discontinues his services to the society voluntarily or otherwise, he shall automatically cease to be a member of the Managing Committee as well as of the General body.

18. Notice of meetings of the managing committee

Notice of the Managing Committee shall be given members three days in advance except in emergent cases.

19. Procedure at the meetings of the committee of management


At every meeting of the committee of Management, the proceedings of the previous meeting shall be read and confirmed. Subject adjourned or undecided at the previous meetings shall be taken up for decisions and no subject shall be adjourned for more than three meetings. The accounts of the society presented by the General Secretary for the previous months or half year shall be approved.


20. Appointment of staff

The General Secretary shall have power to appoint the staff subject to the sanction of Committee of Management.

The Committee of Management shall be the supreme authority to regulate appointments, accept resignations, enforce discipline and dismiss any member of the staff, (whether ministerial, subordinates etc.,) for the misconduct, misbehavior, irregularities. Before such disciplinary action is taken, every opportunity shall be accorded to the person concerned to offer satisfactory explanation or defence.

21. Sub-Committees and Bye-laws

23. Quorum for the General Assembly


One half of the total number of members shall form the quorum. This restriction with regard to quorum shall not apply to adjourned meetings of the General Assembly.


24. The Programme of the General Assembly

(iv) To elect members to the Committee of Management for the ensuing terms after the expiry of the term of the existing committee.

A Special meeting of the General body shall be convened by the Committee of management at their discretion or at the requisition of not less than one fourth of the total number.


